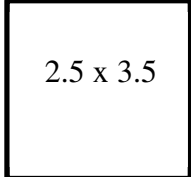

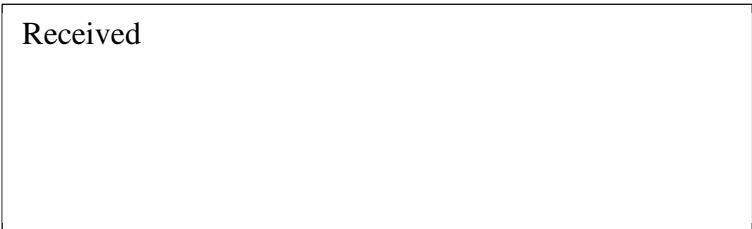

Rules for Renewal of Registration

1. Practitioners who are already registered with Paschim Banga Ayurved Parishad as per IMCC Act 1970 (Act no 48 of 1970) and Section 23 & 24 and / or NCISM Act 2020 (Act no 8 of 35) are enlisted to renew their registration certificate and updation.
2. Renewal of Registration will be processed every 5 years interval from the date of Registration.
3. On the day of Renewal for Registration, the candidates have to be Physically Present with original Registration, Aadhar Card etc. with Xerox Copy as testimonials.
4. Initial Renewal Registration including identity card, the fees for five years Rs. 2300/- otherwise only renewal fees for five years Rs. 1500/- should be deposited by cash.
5. At the time of renewal for any change of - (a) Address, (b) Name/ Surname entry (c) Update Identity Card (a) Rs. 1000/- and (b) Rs. 1000/- (c) Rs. 800/- will be charged separately.
6. Entry for any additional qualification will be charged separately.
7. At every five year interval, at the time of Renewal Registration candidate have to produce Previous Renewal Certificate and identity card.
