With reference to the subject mentioned above, Commission has notified the National Commission for Indian System of Medicine (Ethics and Registration) Regulations, 2023, which was published in Gazette of India on 29.12.2023 vide serial no 870 Under Extraordinary, part-III section -4.

This regulation was prescribed to ensure compliance with the code of professional and ethical conduct through State Medical Council, maintain the State Register/National Register and promote medical ethics. It also provides for disciplinary action against registered medical practitioners for professional or ethical misconducts (such as On-paper teacher & Interns), temporary registration for foreign national and defines the rights and privileges of practitioners. Additionally, it addresses numerous other purposes/sections listed under the NCISM Act, 2020.

Being a State Govt. Authority, you are requested for wide-dissemination of regulation and implementation of the same among the registered ISM Practitioners, as this regulation is very much important for the Stakeholders/Practitioners of ISM.

Therefore, you are requested to instruct, stakeholders of ISM, Ayurveda/Unani colleges of West Bengal, Govt. officials (Deputy Director, Joint Director, Assistant Director, DMO, Medical officers), Private Practitioners to attend a Virtual Conference meeting with on 16.04.2024 from 11:30AM to 01:00 PM. In the said Virtual Conference meeting, Board will brief about the concerned sections of the National Commission for Indian System of Medicine (Ethics and Registration) Regulations, 2023 relating to Rights of Practitioners, Registration related, Temporary registration related, penalty provision in respect of Misconducts, etc.
