Subject: - Guidelines for State ISM Councils in respect of Temporary Registration, Renewal of Registration, Provisional Registration - regarding.

With reference to the subject mentioned above, National Commission for Indian System of Medicine (Ethics and Registration) Regulations, 2023, was published in Gazette of India on 29.12.2023 vide serial no. 870 Under Extraordinary, part-III section -4.

In compliance to the section 10, 27 and 55 of the NCISM Act 2020 and in-compliance to the relevant regulation of National Commission for Indian System of Medicine (Ethics and Registration) Regulations, 2023, Commission/Board have framed the following guidelines:

1. Guidelines for Registrars in respect of Temporary Registration for Practitioners / Teachers / Researcher / Govt. Employee / PG Scholars and others of Indian System of Medicine.
2. Guidelines for the Renewal of Registration for ISM Practitioners.
3. Guidelines for Provisional Registration and Internship Compliance of MES regulations in respect of internship.

Registrars of all respective councils are directed to kindly go through the guidelines and implement the provisions mentioned in the National Commission for Indian System of Medicine (Ethics and Registration) Regulations, 2023 in immediate and efficient manner.

Guidelines for Registrars in respect of Temporary Registration for Practitioners / Teachers / Researcher / Govt. Employee / PG Scholars and others of Indian System of Medicine.

Objective:

The practitioner /teacher/PG student may obtain temporary registration of one state along with permanent registration of another state; for the purpose of practice/employment/Higher Studies /research /any other etc.

Eligibility

- Applicant must possess a recognized medical qualification in Ayurveda, Unani, Siddha or Sowa-Rigpa from their respective States and having permanent registration from the concern state ISM council or Board for the period of 5 years as the case may be.
- Purpose: Eligible for those seeking to practice or pursue additional qualifications, teaching/research/Govt. Jobs or others in these systems of medicine recognized by the National Commission for Indian System of Medicine in other states.

Ineligibility

- Person doing internship shall not be eligible for the temporary registration.

Online / Offline Application Process

- Applicant may apply for the temporary registration through electronic platform as prescribed by the state ISM council or Board.

Offline Form Submission:


- Practitioner shall apply to the concerned state ISM council or to the Board of Ethics and Registration as the case may be in the prescribed format annexed as TR-I
- All State ISM Councils shall maintain a separate register for temporary registration in prescribed uniform format annexed as TR-II.

2. Documentation: Attach necessary documents verifying qualifications and recognition as a practitioner, and intimate to the State Council where registered.

Fee Details

- Prescribed fee for temporary registration shall be Rs. 1000/- (one thousand).
- Mode of Payment: Details regarding the mode of payment (e.g., bank transfer, demand draft) will be specified by the State Medical Council for Indian System of Medicine or the National Commission for Indian System of Medicine, as applicable.

Register Maintenance

- In addition to the online data, separate register shall be maintained for ISM practitioners granted temporary registration, ensuring transparency and regulatory compliance.
 - Same format as that of permanent registration with additional column to enter renewal and total number of durations and state of permanent registration.

Compliance and Reporting

- Practitioners with temporary registration must adhere to the ethical guidelines, standards of professional conduct, and other regulations as prescribed by the National Commission for Indian System of Medicine / Board of Ethics and Registration and as specified in concern state act.
- CME Credit points are not required for renewal of temporary registration, provided practitioner must secure 50 credit points for renewal of permanent registration of state where practitioner is registered.
- When practitioner is taking Temporary registration in another state, it is to be intimated to the other state council where there is permanent registration. The data of permanent registration and temporary registration is to be maintained by both the states ISM councils, through electronic synchronization with Board.


Renewal and Duration

- The temporary registration shall valid for the period of one year only. The period of validity should be specified in the temporary registration certificate.
- The validity of temporary registration shall only one year, it shall be renewed every year till the completion of Ten years, after which the said practitioner is entitled to hold registration of only one state. Dual Temporary Registrations are prohibited.
- If a person pursuing Post Graduation/Higher Studies, he/she shall get Temporary registration from state where he/she is studying (till completion of Course), further the duration of study shall not considered in the duration of Temporary registration of 10 years.

Note: The term Board referred in these guidelines is referred to the Board of Ethics and Registration for Indian System of Medicine constituted under clause (d) of sub-section (1) of section 18 of the NCISM Act 2020.
