CIRCULAR

To,

The Practitioners who have not received their National Registration Certificate.

Subject: Correction of Name, Father's Name, Date of Birth and Other Particulars in the National Registration Certificate applied under the erstwhile CCIM (i.e. b/w 2015-2021) – reg.

With reference to the subject cited above, it is to inform you that many practitioners had applied for the issuance of the Central Registration Certificate during the period of the erstwhile Central Council of Indian Medicine (CCIM) by submitting the prescribed application form along with the requisite fee of Rs. 2,000/-. Consequent upon the dissolution of the Central Council of Indian Medicine and the establishment of the National Commission for Indian System of Medicine (NCISM) under the provisions of the National Commission for Indian System of Medicine Act, 2020, the issuance of the National Registration Certificate (NRC) is being undertaken by the Board of Ethics and Registration (BOER), NCISM.

Further, you have applied under the erstwhile CCIM (i.e. between 2015-2021), however you have not yet received National Registration Certificate, hence an opportunity is being provided to you to correct Name, Father's Name, Date of Birth etc. furnished in your application. A prescribed Correction Format is enclosed for this purpose.

Furthermore, Practitioners are required to submit the duly filled Correction Format, along with supporting documents, to their respective State Indian System of Medicine (ISM) Council/Board for verification and updation of records. The concerned State ISM Council/Board shall verify the corrections, update its records wherever necessary, and forward the duly verified corrected data to the Board of Ethics and Registration, NCISM at the earliest for further processing. The Registrar of State ISM Council will provide the acknowledgement/receiving letter to the practitioners during the submission of Correction Format, a copy of which will be submitted by the practitioner to the Board of Ethics and Registration, NCISM.

It is clarified that practitioners shall not submit the Correction Format directly to the Board of Ethics and Registration, NCISM. The Correction Format shall be submitted to the concerned State ISM Council/Board for verification. Practitioners may contact the Board only after the verified corrected data has been forwarded by the concerned State ISM Council/Board, along with a copy of the acknowledgement/receiving letter received from the State Council.

This is one-time activity, solely for the purpose of allotting National Registration Certificate to the person who has applied for the Central Registration in Erstwhile CCIM.

The Registrars of the respective State ISM Councils are hereby directed to submit the duly filled correction formats received from the practitioners to the Board of Ethics and Registration, NCISM, within 30 days from the date of issuance of this letter. In case the duly filled formats are not received within the stipulated period, the records already available with the Board shall be treated as final and correct.

NOTE: This circular shall not affect or applicable to the person/practitioner who have already got their National Registration Certificate by the Board of Ethics and Registration, NCISM.
